## **PART A - SPECIFICATION**

### **1. Introduction**

Maranoa Regional Council invites expressions of interest from businesses that have an interest in removing all or part of the stockpiled manure from the Roma Saleyards.

### **2. Background**

The Roma Saleyards is located at 44589 Warrego Highway, Roma, described as Part of Lot 24 on Plan 299286 (Roma Saleyards).

Council is conducting this EOI for interested parties to load and remove the manure stockpile for a commercial use.

It is estimated that there is currently 8500 m3 of manure on site for removal.

### **3. Risk, Indemnity and Release**

The successful party will undertake the removal and transportation. All Health, Safety and Environmental obligations must be met while conducting the removal and transportation on manure.

The successful party will be required to release (to the extent permitted by law) and indemnify Council against any liability or loss arising from and any costs, charges and expenses incurred in connection with damage to or loss of anything as well as injury to, or the death of, any person however arising in connection with the use of the tiered seating.

As a condition of the trustee permit, the successful organisation must have public liability insurance of \$20,000,000, plant insurance & WorkCover. This is a standard condition of all Council leases and agreements.
