#### 1. Introduction

Maranoa Regional Council is calling for expressions of interest from persons wishing to enter a licence agreement to keep and graze horse/s in paddocks located at 15-17 Banks Street, located on the map below.

#### 2. Background

Council owned freehold land located at 15-17 Banks Street Yuleba and consists of two parcels of land described as Lots 603 & 604 on Y2211.

Freehold land at 15-17 Banks Street, is two combined allotments and allows for one (1) horse (not a stallion) within the confines of the Local Law.

#### 3. Details of available blocks

#### 3.1 Area

The combined area of the two blocks located at Lots 603 & 604 on Y2211, 15-17 Banks Street, Yuleba is approximately 4,856 sqm.

#### 3.2 Access

Access to Lot 603 & 604 on Y2211 is from Banks Street, Yuleba.

#### 3.3 Fencing

This successful applicant will be responsible for their own fencing and the enclosure must be of a standard to be deemed stock proof and be able to stop horses from escaping the block of land.

#### 3.4 Water


The successful applicant will be responsible for their own water provisions.
