# MESSAGE FROM THE MAYOR, COUNCILLORS & CHIEF EXECUTIVE OFFICER

It is with pleasure that we introduce our Annual Report for 2019/20.

This year was one of transition as we farewelled some Councillors and welcomed 6 new Councillors to Maranoa Regional Council and 3 returning Councillors.

It was certainly a busy start, with a global pandemic coinciding with the start of the new term.

This brought unprecedented challenges in how to navigate for a region not directly affected by illness, but still feeling some effects from a cash flow and business activity perspective.

We saw the region rise to the challenge, and innovation and new business opportunities presented themselves for some.

At Council it accelerated some innovation in how we connect, and the organisation embraced online opportunities to meet and stay in touch. Out of the challenges there will be some positive lasting legacies that will serve us well going forward, given the size of our region.

As well as some unexpected challenges, there were also some important milestones.

From a service perspective, the celebration of 50 years of the Roma Saleyards brought government, community and Council together. There were a number of events that showcased Australia's largest cattle selling centre, culminating in the Australia Day event that was enjoyed by all.

The introduction of the State Government's Waste Levy has changed, and will continue to change, how we manage waste in the region. Being part of the waste levy zone in Queensland has necessitated the implementation of new financial and waste processes.

The Containers for Change recycling program (where residents can receive refunds for eligible containers) was one of the most embraced initiatives ever launched. Council continued the program until it could be transitioned to a local business.

All of those in the waste team and the many helping hands out of normal business hours helped ensure the program's success. We thank and congratulate all those involved.

From a whole of workforce perspective, the certification of our new industrial agreement was a significant milestone for our Council. It was the culmination of many months of negotiations. The respectful and professional approach to negotiations was a credit to all involved. It is wonderful to now have a single agreement in place for the whole workforce, reflective of us being one Council, and one team.

We also congratulate our water, sewerage, gas and quarry teams who met new standards of work practices and achieved third party certification across the three areas of quality, safety and environment for the first time.

At an elected Council level, with the new term of Councillors, came new directions.

For the first time, our Council meetings were digitally recorded and made available on the Council website. It has become a popular way for our community to see first hand how their local government's decision making works. It enables residents to view the meetings from the convenience of their home at any time of the day or night.

Also changing during the year has been how Council engages through information and formal processes.

The new Council has elected to not have portfolios or advisory committees and instead have all Councillors involved in as many engagements as possible, albeit impacted for a while by COVID-19.

Councillors are enjoying meeting residents from across the region, and continuing to support town development associations and groups as well as connecting with local issues.

Councillors are also working to build connections with representatives from other tiers of government and neighbouring Councils to identify opportunities to work together on projects for the benefit of the region.

We express our appreciation for the Australian and Queensland Governments who have again supported the region through approval of a number of significant funding applications.

We thank and acknowledge the efforts of all those who have worked and partnered with Council through the year's highlights, and helped navigate the challenges. A special mention to our teams who provide services and projects for our community on a daily basis.

We look forward to continuing to work with and for our communities.
